NEIGHBORHOOD INFRASTRUCTURE REHABILITATION PROGRAM (NIRP)	RESOLUTION ORDINANCE RECEIVE/FILE	JOHN P. BELLIZZI PUBLIC WORKS DIRECTOR

SYNOPSIS -

The Public Works Department, during the last six years, has developed a wide range of infrastructure maintenance and construction activities performed by in-house crews. The efficiency of these in-house activities has enabled the Department to expand the annual programs completed on the City's arterial and neighborhood right-of-way infrastructure. The results of these expanded programs have shown that the road condition profile of the arterial streets has improved, and in the neighborhood areas, the infrastructure improvements have appeared to motivate owners to make improvements to their property as well. With the objective of enhancing neighborhood property values, the Public Works Department has developed a more concentrated neighborhood infrastructure rehabilitation program (NIRP) utilizing previously proven maintenance and construction techniques.

The proposed FY97 NIRP provides for the rehabilitation of right-of-way infrastructure in designated neighborhood areas. The work to be performed within the program is scheduled to ensure its completion without compromising Citywide maintenance and construction needs. Designated neighborhoods have been prioritized to receive projects based on the length of time they have been included in the Revitalization Program and goals of the designated neighborhood project area action plans. The Public Works Department will provide all planning, direction, and control for the projects.

FISCAL IMPACT -

Funding for the neighborhood infrastructure rehabilitation program is provided for from monies currently allocated in the CIP (\$349,000), Operating Budget (\$840,000), and CDBG (\$325,000), for a total of \$1,514,000 as originally reported to the Council during the course of earlier operating budget and CIP workshops.

RECOMMENDATION -

Authorize City Manager to proceed with NIRP improvements.

BACKGROUND -

The neighborhoods to be included in the NIRP have been selected based on the length of time they have been included in the Revitalization Program. The Community Development Department has assisted in prioritizing the neighborhoods to be included in Phase I and Phase II of the NIRP as shown below:

The Public Works Department has developed an innovative approach to identifying needs, coordinating resources, and scheduling work crews to accomplish the improvements planned for each of the Phase I designated neighborhoods. The work to be completed consists of street, sidewalk, and intake and manhole repair. In addition, neighborhood street trees will be trimmed, required handicap ramp access ramps will be installed, and sanitary sewers cleaned. A listing of the streets to be included by neighborhood and type of activity is shown in Attachment l.

Following selection of the proposed streets to be completed, Public Works and Community Development Department staff conducted a series of meetings to acquire input for the program. Initially, staff oriented a steering group of neighborhood leaders on the NIRP. With their endorsement, staff proceeded to meet with both the Neighborhood Advisory Board and Des Moines Action Board. At those meetings, staff was requested to meet with the individual neighborhoods involved in the program to secure resident input. Subsequent meetings were scheduled and attended in each of the designated neighborhoods included in Phase I of the NIRP. Several suggestions were made by neighborhood residents and incorporated into the proposed program. The Public Works Department now plans to proceed with scheduling the planned improvements.

In summary, the NIRP provides for the rehabilitation of right-of-way infrastructure in designated neighborhood areas and is compatible with completed project area action plans. It is anticipated that the improvements will serve as a catalyst for further tax base improvements by abutting property owners. Designated neighborhoods have been prioritized by the Community Development Department based on the length of time they have been included in the Revitalization Program. As new neighborhoods are added to the designated list, they will be funded in future programs.
