

AGENDA HEADING:

Fee schedule changes related to 2018 Fire Code adoption.

SYNOPSIS:

The fee schedule requires a minor update to accommodate three changes in the types of permits the fire department issues. These changes are minor in nature and will not have a significant impact financially or on fire department inspection procedures. To provide sufficient time to incorporate the new fee structure into the contractor bidding process, the revised fee structure will be effective beginning on April 1, 2020.

FISCAL IMPACT:

Amount: Approximate increase of \$2,000.00 in annual permit revenue.
