AGENDA HEADING:

Hearing on 3226 University Avenue Heating Ventilation and Air Conditioning (HVAC) Replacement: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Central Iowa Mechanical Company, Larry D. Goode, Jr., President, \$441,000.

SYNOPSIS:

This is a public hearing to allow for public input on the 3226 University Avenue HVAC Replacement and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the replacement of the HVAC system for the City facility at 3226 University that is occupied by IMPACT Community Action Partnership and is also an Information Technology (IT) hub.



ADDITIONAL INFORMATION:

• On December 16, 2019, under Roll Call No. 19-1979, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 3226 University Avenue HVAC Replacement, 04-2018-014. The improvement includes the replacement of the existing, inefficient boiler system that was original to the building. The new HVAC system will be comprised of several rooftop units, all having SEER ratings above 18, which is MidAmerican Energy's highest rebate tier. Includes HVAC mechanical systems, electrical connections, structural modifications, roof repair, and utility connections; all in accordance with the contract documents, including Plan File Nos. 605-046/052, located at 3226 University Avenue.

- Sealed bids for said improvement were submitted by the following bidders:

 - o Air-Con Mechanical Corporation, Des Moines, IA

- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on January 14, 2020.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Central Iowa Mechanical Company (Larry D. Goode, Jr., President, 204 S.W. 2nd Street, Des Moines, IA, 50309), in the amount of \$441,000, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
