AGENDA HEADING:

Hearing on 2020 Hot Mix Asphalt (HMA) Resurfacing Program Contract 1: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Grimes Asphalt and Paving Corporation, Timothy Mallicoat, President, \$1,308,543.50.

SYNOPSIS:

This is a public hearing to allow for public input on the 2020 HMA Resurfacing Program Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for full depth patching, scarification or full depth removal of existing asphalt streets, and HMA overlay of arterial and residential streets Citywide.



ADDITIONAL INFORMATION:

- On January 13, 2020, under Roll Call No. 20-0014, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2020 HMA Resurfacing Program Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2020 HMA Resurfacing Program Contract 1, 06-2019-015. The improvements include furnishing labor, equipment, and materials all in accordance with the contract plans and documents, including Plan File Nos. 614-030/058, at the following locations all within the City:
 - Full depth removal of existing pavement, installation of modified subbase and HMA;
 also, other incidental items in accordance with the contract documents at the following locations:
 - ➤ Rittenhouse Street S.W. 22nd Street to S.W. 28th Street
 - ➤ North Valley Drive 56th Street to Muskogee Avenue

- Scarification of existing asphalt streets, furnish and place HMA, furnish and place pavement markings, and other incidental items, in accordance with the contract documents at the following locations:
 - ➤ Echo Valley Drive from S.W. 42nd Street to Norwalk City Limits (cost shared with city of Norwalk)
 - ➤ S.E. 1st Street Indianola Avenue to Scott Avenue
 - ➤ Hull Avenue E. 14th Street to Dixon Street
 - ➤ Guthrie Avenue I-235 to Hubbell Avenue.
- Sealed bids for said improvement were submitted by the following bidders:
 - o Grimes Asphalt and Paving Corporation, Des Moines, IA
 - o OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, Ankeny, IA
 - o InRoads, LLC, Des Moines, IA
- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on January 28, 2020.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Grimes Asphalt and Paving Corporation (Timothy Mallicoat, President, 5550 NE 22nd Street, Des Moines, IA, 50313), in the amount of \$1,308,543.50, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
