#### **AGENDA HEADING:**

Hearing on Fourmile Community Center Renovation and Sprinkler System: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Koester Construction Company, Inc., Paul Koester, President, \$519,000.

#### **SYNOPSIS:**

This is a public hearing to allow for public input on the Fourmile Community Center Renovation and Sprinkler System and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project adds a fire suppression system and interior renovations to the kitchen, rental space and fitness room to better utilize space in the community recreation center, to better serve clients' current needs and provide for flexibility as future needs evolve.


Amount: \$519,000 Construction Contract (\$500,500 City Engineer's Estimate)

<u>Funding Source</u>: 2019-2020 CIP, Page Park – 8, Community Recreation Center Improvements, PK033, Being: \$413,500 G.O. Bonds issued, \$45,000 transfer from BL110, and \$60,500 transfer from BL074.

## **ADDITIONAL INFORMATION:**

• On February 24, 2020, under Roll Call No. 20-0318, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Fourmile Community Center Renovation and Sprinkler System. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Fourmile Community Center Renovation and Sprinkler System, 11-2019-012. The improvements include the addition of a new fire suppression sprinkler system, updates to the fire alarm system, reconfigure areas to better utilize space, renovation of the kitchen and rental space, and relocation of the fitness equipment room; all in accordance with the contract documents, including Plan File Nos. 602-202/267, located at Fourmile Community and Recreation Center, 3711 Easton Boulevard.

- Sealed bids for said improvement were submitted by the following bidders:
  - o Koester Construction Company, Inc., Grimes, IA
  - o Keystone Construction Services, LLC., Norwalk, IA
  - o Cerebral Group, LLC, Des Moines, IA
  - o Brocon Services LLC, Johnston, IA
  - o JPG Company, LLC, Grimes, IA
  - o Accurate Commercial, Des Moines, IA bid not read, bid bond not signed
- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on March 24, 2020.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Koester Construction Company, Inc., (Paul Koester, President, 3050 SE Enterprise Drive, Suite A, Grimes, IA, 50111), in the amount of \$519,000, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Fourmile Community Recreation Center was built in 1973 and is 14,494 square feet in size.
- Recent updates to the facility include:
  - o Skatepark constructed in 2000
  - o New roof in 2015
  - o Renovated parking lot in 2017
  - o New playground in 2017
  - Check-in desk added in 2018
  - o Windows replaced in 2019
