AGENDA HEADING:

Ordering construction of the following: 6th Avenue Streetscape - College Avenue to University Avenue - Receiving bids, (6-16-20), and Setting date of hearing, (7-13-20). Construction Estimate - \$3,867,486.70.

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project includes streetscape enhancements, roadway reconfiguration from five (5) travel lanes to three (3) travel lanes, improvements to pedestrian and bicycle facilities along the corridor, street tree planting, and constructing green infrastructure components such as biocells and permeable pavers.



<u>Funding Source</u>: 2020-21 Pending CIP, Page Street – 42, Sixth Avenue Streetscape, ST266, Being: \$483,000 (maximum) in Transportation Alternative Program (TAP) funds being 80% eligible construction costs under TAP-T-1945(851)--8V-77; \$1,050,000 (maximum) in Surface Transportation Block Grant (STBG) funds; being 80% eligible construction costs under TAP-T-1945(851)--8V-77; \$900,000 in private donations from the 6th Avenue Corridor; \$153,400 in Des Moines Water Works for water main relocation; the remaining \$1,281,087 in G.O. Bonds.

ADDITIONAL INFORMATION:

• The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 6th Avenue Streetscape - College Avenue to University Avenue, 04-2018-017. The improvement includes pavement removals, installation of Portland Cement Concrete (PCC) sidewalks and driveways, curb, storm sewer, intakes, subdrain, site furnishing, biocells, permeable pavers, traffic signalization, pavement scarification, Hot Mix Asphalt (HMA) paving, tree planting, seeding, and miscellaneous associated work to complete the streetscape; in accordance with the contract documents, including Plan File Nos. 618-001/152, on 6th Avenue from College Avenue to University Avenue.

- The estimated construction cost is \$3,867,486.70. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- The 6th Avenue Streetscape Project includes streetscape enhancements, roadway reconfiguration from five (5) travel lanes to three (3) travel lanes, improvements to pedestrian and bicycle facilities along the corridor, street tree planting, and constructing green infrastructure components such as biocells and permeable pavers.
- The Project will be implemented in three (3) phases, starting from the north end of the corridor:
 - o Phase 1: Hickman Road to College Avenue
 - o Phase 2: College Avenue to University Avenue
 - o Phase 3: University Avenue to I-235
- Phase 1 of the 6th Avenue Streetscape, from College Avenue to Hickman Road, is approximately 85% complete with construction and scheduled to be complete in the summer 2020.
- Phase 2 of the 6th Avenue Streetscape, from College Avenue to University Avenue, is anticipated to start construction late summer 2020 and be completed by end of 2021.
