AGENDA HEADING:

Hearing on 2020-2021 Hot Mix Asphalt (HMA) Pavement Scarification and Resurfacing: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Grimes Asphalt and Paving Corporation, Timothy Mallicoat, President, \$291,238.50.

SYNOPSIS:

This is a public hearing to allow for public input on the 2020-2021 HMA Pavement Scarification and Resurfacing and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the timely maintenance of residential and arterial streets utilizing surface scarification and hot mix asphalt overlay to improve the surface condition, extend the useful service life of the streets, and to construct Americans with Disabilities Act (ADA) compliant sidewalk curb ramps within the project areas.

FISCAL IMPACT:

Amount: \$291,238.50 Construction Contract (\$387,000 City Engineer's Estimate)

Funding Source: 2020-21 CIP, Page Street – 30, Public Works - Asphalt Road Improvements, ST003, G.O. Bonds to be issued

ADDITIONAL INFORMATION:

- On April 20, 2020, under Roll Call No. 20-0605, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2020-2021 HMA Pavement Scarification and Resurfacing. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2020-2021 HMA Pavement Scarification and Resurfacing, 06-2020-006. The improvement includes scarification only of 2-inch average depth of asphalt street surfaces with specified milling machine and equipment in a cooperative effort with the City of Des Moines Public Works Department, together with other incidental and related work; all in accordance with the contract documents at the following locations within the City of Des Moines:

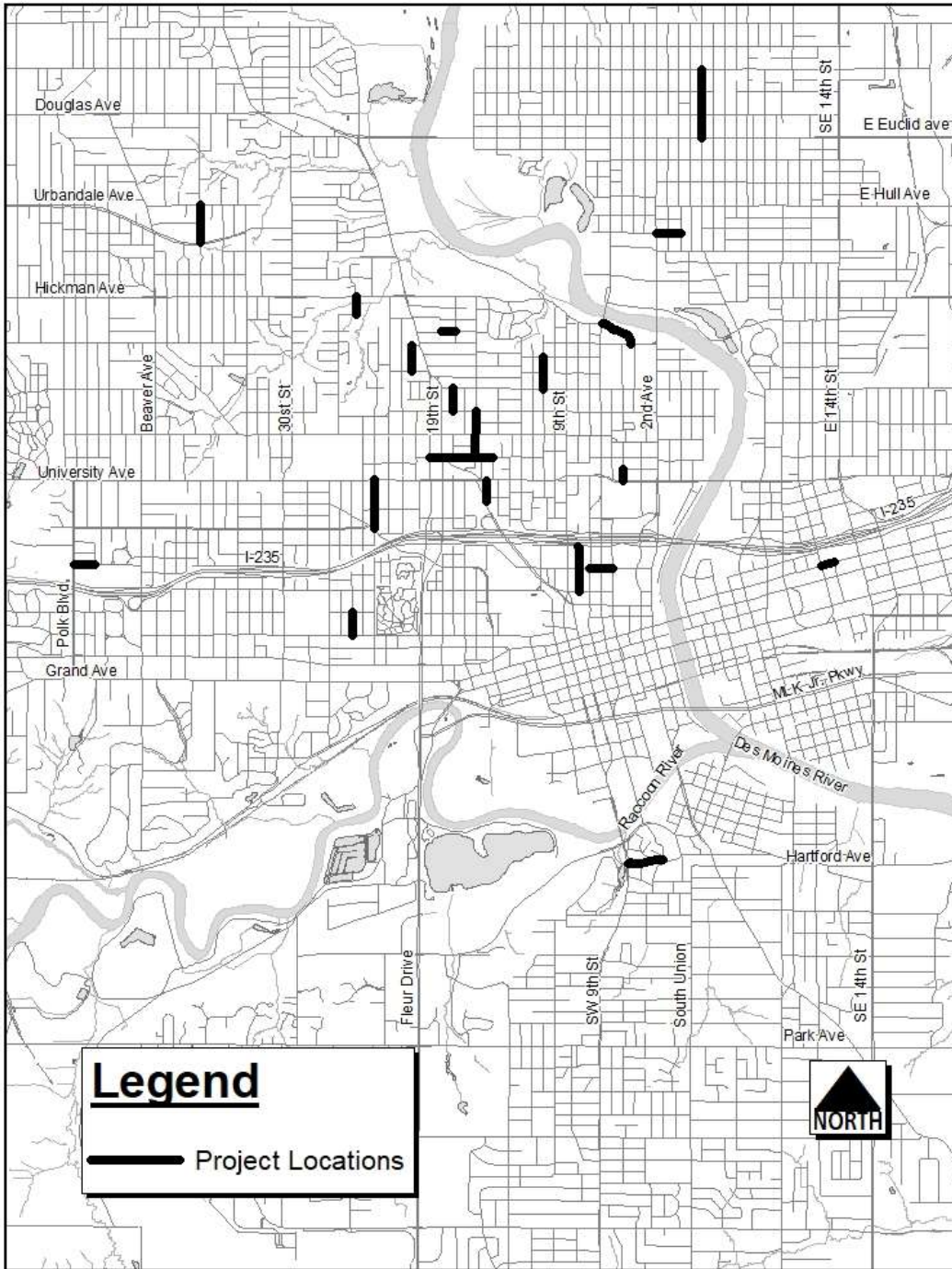
4th Street from University Avenue to Creighton Avenue

24th Street from Cottage Grove Avenue to University Avenue
26th Street from Lincoln Avenue to Hickman Road
26th Street from Pleasant Street to Woodland Avenue
38th Street from Urbandale Avenue to Adams Avenue
Allison Avenue from 18th Street west to alley
Arlington Avenue from Franklin Avenue to 6th Avenue
Bancroft Street from Courtland Drive to S.W. 9th Street
Carpenter Avenue from 15th Street to M. L. King Jr. Parkway

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Grimes Asphalt and Paving Corporation, Timothy Mallicoat, President, 5550 NE 22nd Street, Des Moines, IA, 50313 in the amount of \$291,238.50, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
