AGENDA HEADING:

Subdivision improvement bond reduction for Summersfield Plat 4.

SYNOPSIS:

Recommend Council approve the reduction of the surety for subdivision improvements in the amount of \$12,790 for the Summersfield Plat 4 subdivision, since partial completion of the required improvements have been completed.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- On October 8, 2008, the City Council approved and accepted a subdivision improvement bond required for infrastructure in the amount of \$25,580 from Merchants Bonding Company for the Summersfield Plat 4 Subdivision. The developer has requested a reduction in the required surety since much of the subdivision improvement work has been completed. The installation of 559 lineal feet of a 5-foot public sidewalk is still remaining and will still require surety in the amount of \$12,790 to make certain that the remaining improvements will be in place when the development of the plat is completed.
- The plat consists of a total of 7.38-acres of land, including one (1) 6,006-square-foot outlot for a fire access road, and one (1) lot for road right-of-way, all zoned Planned Unit Development (PUD). The proposed development will consist of 21 single-family dwellings and will comply with the zoning conditions per the PUD Concept Plan.
