# AGENDA HEADING:

Hearing on Glendale Cemetery Road Reconstruction Phase 3: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Hawkeye Paving Corporation, Anthony L. Perkins, President, \$607,870.

#### SYNOPSIS:

This is a public hearing to allow for public input on the Glendale Cemetery Road Reconstruction Phase 3 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for full reconstruction of selected roads in Glendale Cemetery. This will address the deteriorated road conditions in Glendale Cemetery, which will provide for better access to the cemetery for the public.



## **ADDITIONAL INFORMATION:**

- On June 8, 2020, under Roll Call No. 20-0884, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Glendale Cemetery Road Reconstruction Phase 3. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Glendale Cemetery Road Reconstruction Phase 3, 11-2020-005. The improvement includes reconstruction of Glendale Cemetery roads including pavement removal, intake removal, intake construction, cement subgrade treatment, Portland Cement Concrete (PCC) curb and gutter, Hot Mix Asphalt (HMA) paving, backfilling, seeding and restoration, and other miscellaneous work; all in accordance with the contract documents, including Plan File Nos. 619-001/044 in Glendale Cemetery at 4903 University Avenue.
- Sealed bids for said improvement were submitted by the following bidders:

- The bids were received and opened at a public meeting presided over by the Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on June 23, 2020.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Hawkeye Paving Corporation, (Anthony L. Perkins, President, 801 42nd Street South, Bettendorf, IA, 52722) in the amount of \$607,870, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
