AGENDA HEADING:

Approval of Amendment to Robert D. Ray Asian Garden Maintenance and Repair Agreement by and between the City of Des Moines and the Des Moines River Front Development Authority (RDA).

SYNOPSIS:

Staff recommends approval of Amendment to Robert D. Ray Asian Garden Maintenance and Repair Agreement by and between the City of Des Moines and the Des Moines RDA.

FISCAL IMPACT: NONE

ADDITIONAL INFORMATION:

- In February of 2017, severe vandalism was experienced at the Robert D. Ray Asian Gardens. Shortly thereafter the RDA began planning for repairs as well as site improvements that would make the site more financially sustainable and that would add site improvements that would encourage increased annual uses, therefore assist with reducing vandalism. The RDA has raised over \$1.5 million for the proposed repairs and improvements, as well as increase the endowment that the RDA holds and manages to finance the annual maintenance.
- Significant terms in this amendment include:
 - The area under agreement is being expanded to the north to allow additional walkways and landscaping and construction of a trail that extends through the site.
 - o RDA is responsible for funding the design and construction.
 - o RDA is responsible for obtaining and paying for all applicable permits.
 - RDA is responsible for providing all plans and specifications for the Improvements (Plans and Specifications) to the City for approval by the Parks and Recreation Director and City Engineer.
 - o RDA is responsible for obtaining the following board and commission approvals for the construction of a City facility:
 - ➤ Plan and Zoning Commission Completed
 - ➤ Parks and Recreation Board Completed
 - Urban Design Review Board Completed
 - ➤ Building and Permit Department After City Council Consideration
 - Access Advisory Board Completed

- RDA shall commence construction of the Improvements by no later than September 1, 2020, and shall complete construction, including landscaping, by no later than September 1, 2021.
- City agrees to accept ownership of the improvements constructed under this
 Amendment. Acceptance of ownership of the improvements shall be subject to the
 verification of the City Engineer that the project has been completed in compliance with
 the approved Plans and Specifications.
- Brief history and term highlights of the Robert D. Ray Asian Gardens:
 - The City entered into an agreement with the Chinese Cultural Center of America (CCCA) in 2005 for the construction of the site and site improvements and provided a \$25,000 grant to support the project.
 - Agreement amended in 2007 to clarify City funds to be used for the construction of Character Stone Garden and maintenance responsibilities.
 - o City provides programming (rental reservations), graffiti removal and snow removal.
 - o City establishes hours and rules consistent with similar parks and facilities.
 - Second amendment approved by City Council in August of 2011. Amendment transferred non-city responsibilities from CCCA to RDA as CCCA notified City that they could not deliver their maintenance obligations.
 - o The term of the agreement expires on October 24, 2025.
