ADDITIONAL INFORMATION:

- The DMMHA received funding last year from HUD for three (3) full-time program FSS Coordinators to administer the Family Self Sufficiency (FSS) Program. The purpose of the FSS Program is to promote the development of local strategies to coordinate the use of Housing Choice Voucher and Public Housing assistance with public and private resources to enable participating families to increase earned income and financial literacy, reduce or eliminate the need for welfare assistance, and make progress toward economic independence and selfsufficiency.
- The FSS Coordinators provide individual case management to assist participants in achieving goals to become self-sufficient. FSS Coordinators provide referrals, training, education, and job development skills to enrolled participants. The DMMHA has provided such a program since 1985 and provided case management to 225 FSS participants during the Notice of Funding Availability target period (January 1, 2019 to December 31, 2019). During the target period, 22 FSS participants graduated successfully from the program.
