AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Code corrections to correct street name—E Glenwood Drive, east of SE 14th Street.
- B. Code corrections to match field conditions—Martin Luther King Jr Parkway from Glennor Road to Madison Avenue.



ADDITIONAL INFORMATION:

A. During a review of the Municipal Code it was discovered that the street name for E Glenwood Drive is incorrectly listed as "Glenwood Drive" in Section 114-3235 of the Municipal Code. The proposed code changes will update the Municipal Code to reflect the correct street name. These changes will not affect the current parking restrictions. The following revisions to the Municipal Code will place these changes into effect.



Sec. 114-3235. East Glenwood Drive--Southeast Fourteenth Street to cul-de-sac east.

<u>East</u> Glenwood Drive, on the south side, from Southeast Fourteenth Street to Southeast Seventeenth Street, no parking any time.

<u>East</u> Glenwood Drive, on the north side, from Southeast Fourteenth Street to a point 75 feet east thereof, no parking any time.


<u>East</u> Glenwood Drive, on the north side from a point 50 feet west of Southeast Seventeenth Street (north leg) to a point 50 feet east of Southeast Seventeenth Street (north leg), no parking any time.

<u>East</u> Glenwood Drive, on the north side, from Southeast Seventeenth Street (south leg) to a point 100 feet west thereof, no parking any time.

<u>East</u> Glenwood Drive, on the south side from Shadow Creek Lane to and including the cul-desac east of Deerpath Court, no parking any time.

B. During a field review it was discovered that the Municipal Code does not match the field conditions and signage on the west side of Martin Luther King Jr Parkway between Glennor Road and Madison Avenue. The proposed code changes will modify the Municipal Code to

match field conditions. The following revisions to the Municipal Code will place these changes into effect.



Sec. 114-3473. Martin Luther King Jr Parkway—Euclid Avenue to Madison Avenue.

Martin Luther King Jr. Parkway, on the west side, from a point 170 feet south of Madison Avenue to Madison Avenue, no parking any time.
