# **ADDITIONAL INFORMATION:**

• The City's current virtual desktop infrastructure (VDI) is running on end-of-life servers. Information Technology Department needs to replace and rearchitect the VDI to support moving from physical desktops to a modern virtual desktop environment. VDI supports a mobile workforce, simplifies the management of desktop security patching, and allows for greater business continuity in the case of office moves or evacuations. This project will also enable the City to replace physical desktop PCs with virtual desktops to diminish the need for cyclical PC replacement, thus reducing hardware costs and management overhead.
