This is a public hearing to allow for public input on the 2021 Traffic Signal Replacement Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project includes replacement of traffic signals at the intersection of 56th Street and Grand Avenue and the intersection of 42nd Street and Grand Avenue.



ADDITIONAL INFORMATION:

• On October 5, 2020, under Roll Call Number 20-1547, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2021 Traffic Signal Replacement Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2021 Traffic Signal Replacement Contract 1, 04-2021-008. The improvement includes new traffic signals, vehicle detector loops, Portland Cement Concrete (PCC) pavement, PCC sidewalks, pavement markings, modular block retaining wall, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 619-245/281, located at the intersection of 56th Street and Grand Avenue and the intersection of 42nd Street and Grand Avenue.
