AGENDA HEADING:

SYNOPSIS:

The project includes replacement of traffic signals at the intersection of 6th Avenue and Holcomb Avenue and the intersection of S.E. 5th Street and Indianola Avenue.



ADDITIONAL INFORMATION:

- On October 19, 2020, under Roll Call No. 20-1641, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2021 Traffic Signal Replacement Contract 2. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2021 Traffic Signal Replacement Contract 2, 042021009. The improvement includes new traffic signals, vehicle detector loops, Portland Cement Concrete (PCC) curb and gutter, PCC sidewalks, pavement markings, modular block retaining wall, and other incidental items; all in accordance with the contract documents, including Plan File Nos. 620-013/056, located at the intersection of 6th Avenue and Holcomb Avenue and the intersection of S.E. 5th Street and Indianola Avenue.

Capitol Circle, Grimes, IA, 50111), in the amount of \$464,846.87 and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
