AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement (PSA) with Foth Infrastructure & Environment LLC for additional professional services for Western Ingersoll Sewer Separation Phase 1, for an amount not to exceed \$126,100.

SYNOPSIS:

Recommend approval of Supplemental Agreement No. 1 to the PSA with Foth Infrastructure & Environment LLC (Patrick P. Kueter, Principal-in-Charge, 8191 Birchwood Court, Suite L, Johnston, Iowa, 50131), for an additional amount not to exceed \$126,100, based on hourly labor rates and reimbursable costs, to provide additional design phase services for the Western Ingersoll Sewer Separation Phase 1.

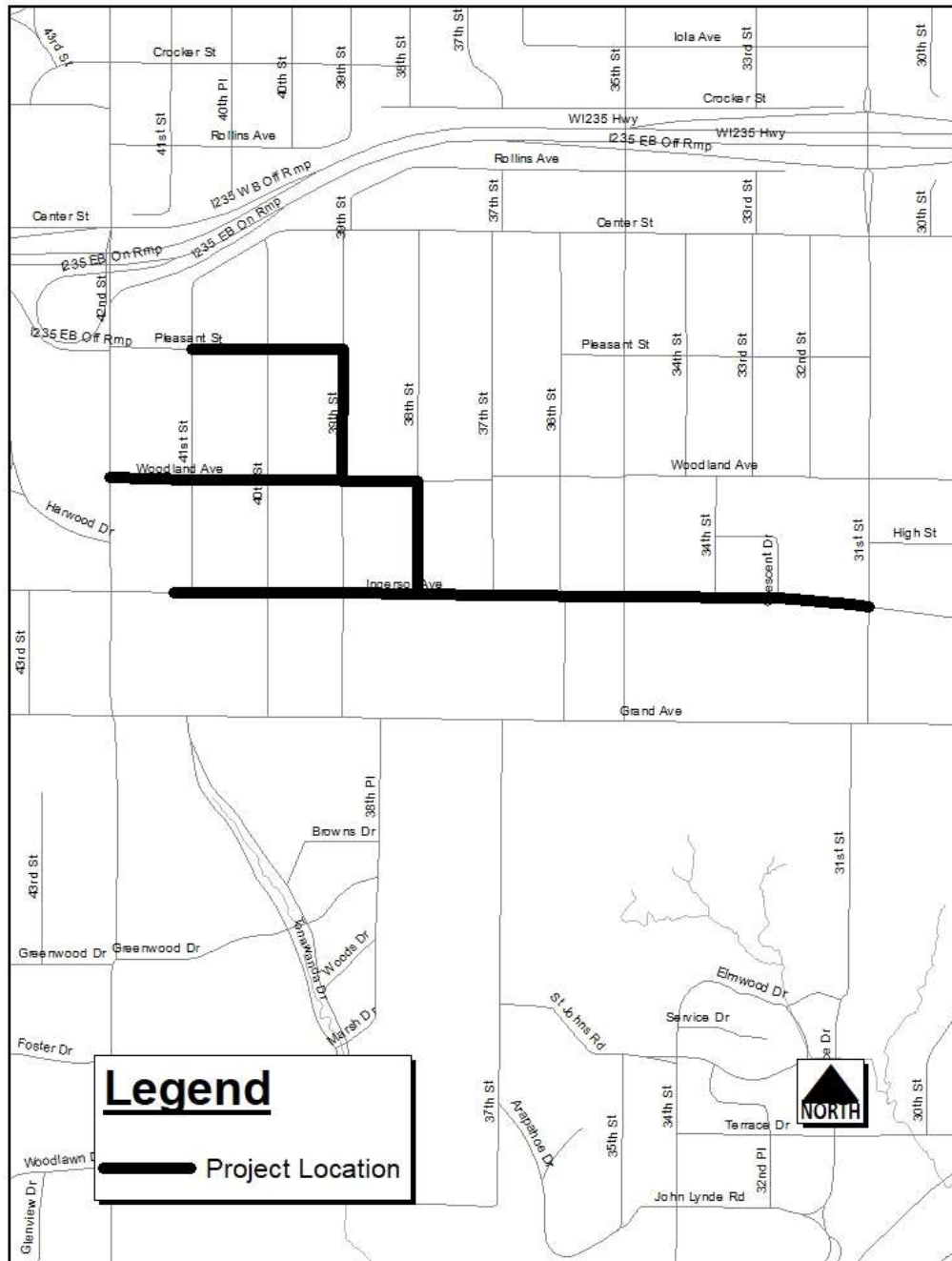

ADDITIONAL INFORMATION:

- On December 16, 2019, by Roll Call No. 19-1981, City Council approved the PSA with Foth Infrastructure & Environment LLC for a total cost not to exceed \$770,070, to provide design phase services for Phase 1 improvements of the Western Ingersoll Run basin, and pipeline televising services for Phases 1, 2, and 3 of the Western Ingersoll basin.
- Staff has negotiated Supplemental Agreement No. 1 to the Agreement for Professional Services with Foth Infrastructure & Environment LLC for an additional amount not to exceed \$126,100, based on hourly rates and reimbursable costs, to provide additional professional services including:
 - Design phase services needed to accommodate the future streetscape and reconfiguration of westbound Ingersoll Avenue from 35th Street to 100 feet west of 41st Street and incorporate new and modified elements into the construction documents for the Western Ingersoll Sewer Separation Project – Phase 1.

- Additional subsurface utility exploration to determine elevations of the existing utilities at critical crossing locations.
