

ADDITIONAL INFORMATION:

- The Hubbell Avenue Reconstruction project includes new street lighting. Now that construction for the new roadway has been completed, MidAmerican is ready to install the new streetlights along this section of roadway. MidAmerican Energy prepared plans to install new galvanized poles with LED fixtures and underground wiring along the project. These poles and fixtures will be owned and maintained by MidAmerican Energy.
- MidAmerican Energy has indicated the streetlights would commence being installed approximately six (6) to eight (8) weeks after receipt of this executed Agreement.
