### **AGENDA HEADING:**

Approving Supplemental Agreement No. 1 to the Professional Services Agreement (PSA) with Stanley Consultants, Inc. for additional design services for Dean Avenue Reconstruction – E. 26th Street to Redhead Road, not to exceed \$41,270.

#### **SYNOPSIS:**

Recommend approval of Supplemental Agreement No. 1 to the PSA with Stanley Consultants, Inc., Kate Harris, President and CEO, 225 Iowa Avenue, Muscatine, Iowa 52761, for an additional amount not to exceed \$41,270, based on hourly rates and reimbursable costs, to provide additional design services for Dean Avenue Reconstruction – E. 26th Street to Redhead Road.



#### ADDITIONAL INFORMATION:

- The Dean Avenue Reconstruction E. 26th Street to Redhead Road project will consist of a complete reconstruction of the roadway. The consultant will develop alternate cross sections for consideration and selection by the City prior to commencing with the development of design plans. Construction is anticipated to commence in the 2022 calendar year.
- On December 2, 2019, by Roll Call No. 19-1900, City Council approved the PSA with Stanley Consultants, Inc. to provide design phase services for Dean Avenue Reconstruction E. 26th Street to Redhead Road, not to exceed \$176,918.
- Staff has negotiated Supplemental Agreement No. 1 to the Agreement for Professional Services with Stanley Consultants, Inc. for a total additional amount not to exceed \$41,270, based on hourly rates and reimbursable costs, for additional design phase services for the Dean Avenue Reconstruction E. 26th Street to Redhead Road project, including:
  - Perform heavy cleaning of 6,100 feet of existing sanitary sewer to clear in preparation for sewer televising and design of replacement of the sewer.

- Preliminary and final design services for replacement of existing sanitary sewer within the project limits.
- o Preliminary and final design services for a new 10-foot-wide shared use path along the south side of Dean Avenue within the project limits.
