AGENDA HEADING:

Acceptance of a proposal from MidAmerican Energy Company to remove existing utility poles and relocate overhead utilities underground for E. 2nd Street Reconstruction from E. Court Avenue to Iowa Interstate Railroad, in an estimated amount of \$140,334.05.

SYNOPSIS:

Recommend acceptance of a proposal from MidAmerican Energy Company, 200 SE 3rd Street, Des Moines, Iowa, 50309, to relocate existing overhead utilities underground for E. 2nd Street Reconstruction from E. Court Avenue to Iowa Interstate Railroad.

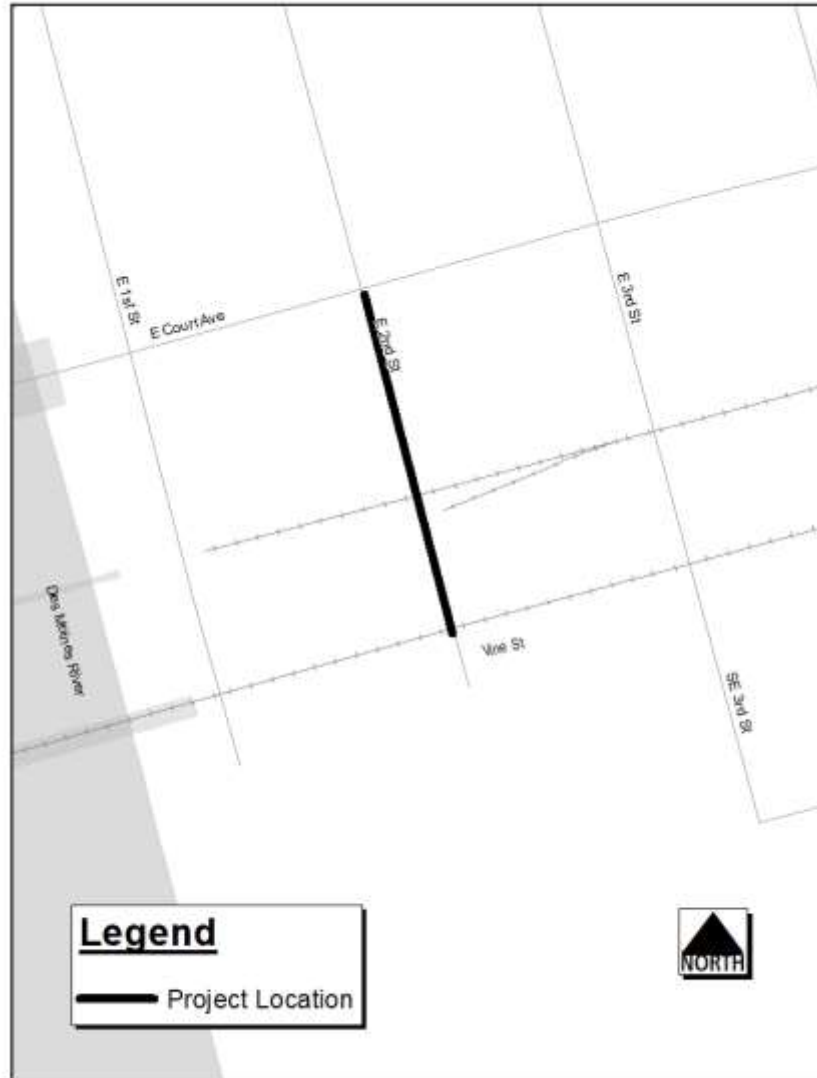
FISCAL IMPACT:

Amount: \$140,334.05

Funding Source: 2021-2022 CIP, Page 133, Market District Infrastructure Improvements, ST282, Tax Increment Funding Bonds.

ADDITIONAL INFORMATION:

- The E. 2nd Street Reconstruction from E. Court Avenue to Iowa Interstate Railroad project includes complete pavement reconstruction of E. 2nd Street between E. Court Avenue and the Iowa Interstate Railroad tracks, including new concrete pavement and curbs and gutters, new sidewalks along both sides of the street, storm sewer installation, landscaping and tree planting, and installation of bioretention cells to help capture and infiltrate stormwater runoff from impervious surfaces. This project design and schedule has been coordinated with private development to the south in the Market District. Construction of this project is anticipated to begin late summer 2021 and be completed by early summer 2022.
- The proposal provides for MidAmerican Energy Company to remove existing utility poles and relocate its facilities underground along the project area adjacent to E. 2nd Street. The underground facilities will be owned and maintained by MidAmerican Energy. This proposal also includes the installation of new black streetlight poles designed to accommodate banners. The estimate from MidAmerican Energy for the work is \$140,334.05 and is budgeted as part of the Market District Infrastructure Improvements project costs.
