AGENDA HEADING:

Request acceptance of grant performance period extension for the Project Safe Neighborhood grant through the Governor's Office of Drug Control Policy designated to reimburse law enforcement overtime associated with mid to high-level narcotic investigations.

SYNOPSIS:

The City Police Department requests approval to accept an extension of the performance period for the grant award from the Governor's Office of Drug Control Policy in the amount of \$67,708. The new performance period would be November 25, 2019, through December 31, 2021 with no matching funds required. The funding is directed to support law enforcement overtime related to the investigation of cases relating to the transportation and/or distribution of dangerous and illegal narcotics in city neighborhoods.

ADDITIONAL INFORMATION:

• The Police Department currently works closely with the Governor's Office of Drug Control Policy and other agencies to investigate drug related cases. The grant funds were originally accepted during the December 16, 2019 meeting with a grant period of November 25, 2019 to October 31, 2020. This grant operational period was extended until June 30,2021 with the extension approved and accepted by City Council during October 5, 2020 meeting. This communication requests the acceptance of an additional extension of the grant period through December 31, 2021. The funds are strictly dedicated to support officer overtime related to cases involving the possession, distribution, and transportation of illegal narcotics within city neighborhoods.
