## **AGENDA HEADING:**

Hearing on 2021 Sewer Repair Contract 1: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as On Track Construction, LLC, Matthew Runge, President, \$1,687,000.

### **SYNOPSIS:**

This is a public hearing to allow for public input on the 2021 Sewer Repair Contract 1 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the repair and replacement of deteriorated storm and sanitary sewer infrastructure at multiple locations in the City.

#### **FISCAL IMPACT:**

Amount: \$1,687,000 construction contract (\$1,750,000 City Engineer's Estimate)



### **ADDITIONAL INFORMATION:**

• On June 14, 2021, under Roll Call No. 21-0831, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2021 Sewer Repair Contract 1. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2021 Sewer Repair Contract 1, Activity ID 08-2021-001. The improvement includes the construction of storm sewer, sanitary sewer, manholes, intakes, Portland Cement Concrete (PCC) pavement, Hot Mix Asphalt (HMA) pavement, earthwork and grading, rip rap, erosion control, fencing, seeding, sodding,
