AGENDA HEADING:

Approving the purchase of a replacement sewers inspection vehicle and associated equipment for use in the Public Works Department.

SYNOPSIS:

Recommend approval to purchase one (1) replacement vehicle with associated sewer inspection equipment utilizing HGACBuy purchase contract number SC01-21A from The Charles Machine Works, Inc. (dba Subsite Electronics), 1950 W. Fir Street, Perry, OK 73077 (Rick Johnson, CEO), in the amount of \$239,587.89.

FISCAL IMPACT:

Amount: \$239,587.89

Funding Source: 2021-2022 Operating Budget, Page 81, I201 Equipment Replacement

ADDITIONAL INFORMATION:

- An existing van with associated sewers inspection equipment that meets replacement criteria was approved for replacement by the Fleet Oversight Committee and included as part of the 5-year vehicle and equipment replacement plan.
- The onboard installed inspection equipment has upgraded technology for routine and emergency televising of the City's sewers system and is compatible with the other televising equipment in operation.
- Although there are currently all-electric vans in this vehicle class, the onboard televising inspection equipment requires onboard generation of power for operation and control of the ambient environment for operators; therefore, an all-electric powered van is not an option for this application. Electric vans will be evaluated for future replacement of vans that do not require onboard power generation. The vehicle and onboard generator will utilize up to B20 cleaner burning biodiesel fuel.
