• This request is to authorize the Finance Department's Procurement Division to increase a FY2022 blanket purchase order to 3R Painting and Kats Painting for miscellaneous, as-needed graffiti removal services. This service provides graffiti removal services on City-owned property as well as on private property where it is deemed a nuisance by a property owner, citizen, or City staff. This increase in funding is needed to continue this service. There has been an increase in very large and hard to access graffiti, resulting in the need to rent specialized equipment to reach the removal.
