AGENDA HEADING:

Acceptance of a proposal from MidAmerican Energy Company to install new LED streetlights for the E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street, estimated at \$255,147.96.

SYNOPSIS:

Recommend acceptance of a proposal from MidAmerican Energy Company, 200 SE 3rd Street, Des Moines, IA, 50309, to install new LED streetlights along E. Douglas Avenue between E. 42nd Street and Village Run Drive for the City's public improvement project, E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street.

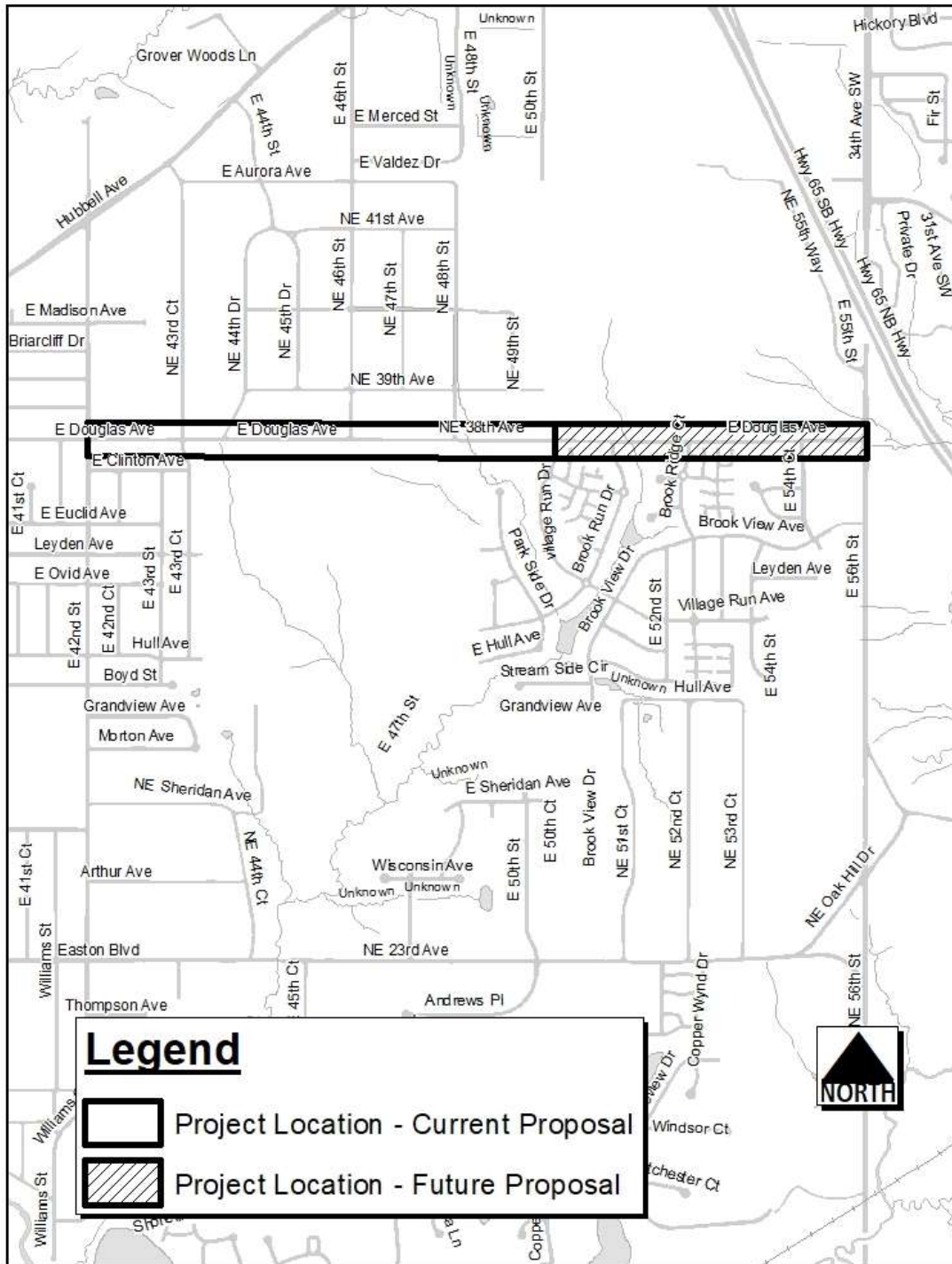

ADDITIONAL INFORMATION:

- On March 8, 2021, under Roll Call Number 21-0431, City Council held a public hearing on the E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street, and approved plans, specifications, form of contract documents, engineer's estimate, receive and file bids and designating lowest responsible bidder as Elder Corporation (Jared R. Elder, II, President), for \$6,168,000. Also, on March 8, 2021, under Roll Call Number 21-0432, City Council approved the contract and bond and permission to sublet for the E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street.
- The E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street project includes new LED streetlighting.
- At the request of the City, MidAmerican Energy Company provided a proposal to install 34 new LED streetlights on galvanized poles along E. Douglas Avenue between E. 42nd Street and Village Run Drive, at an estimated cost of \$255,147.96. Upon acceptance of the proposal, MidAmerican Energy Company will install the new streetlights in coordination with the City's public improvement project, E. Douglas Avenue Reconstruction – E. 42nd Street to E. 56th Street.

- MidAmerican Energy will be providing a separate proposal to install new LED streetlights along E. Douglas Avenue between Village Run Drive and E. 56th Street.
