AGENDA HEADING:

Hearing on Skywalk heating, ventilation, and air conditioning (HVAC) Replacement Phase 4: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Stein Heating & Cooling Inc., Brian P. Stein, President, \$218,000.

SYNOPSIS:

This is a public hearing to allow for public input on the Skywalk HVAC Replacement Phase 4 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project which is comprised of HVAC replacement and miscellaneous improvements for skywalk bridges 4E-5E and 6D-6E.



ADDITIONAL INFORMATION:

- On October 4, 2021, under Roll Call No. 21-1455, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Skywalk HVAC Replacement Phase 4. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Skywalk HVAC Replacement Phase 4, Activity ID 04-2022-002. The improvement includes the removal of existing HVAC units and installation of two (2) new HVAC units, electrical connections, structural modifications, access ladder installation, security fence installation, and traffic control; all in accordance with the contract documents, including Plan File Nos. 630-117/124, located at skywalk bridges identified as 4E-5E (vicinity of 5th Avenue and Grand Avenue), and 6D-6E (vicinity of 6th Street and Locust Street).
- Sealed bids for said improvement were submitted by the following bidders:
 - o Stein Heating & Cooling Inc., Webster City, IA, Low Bid
 - o Excel Mechanical Company, Inc., Des Moines, IA
 - o Air-Con Mechanical Corporation, Des Moines, IA

- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on October 19, 2021.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Stein Heating & Cooling Inc. (Brian P. Stein, President, 1120 E. 2nd Street, Webster City, IA, 50595), in the amount of \$218,000, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
