## **ADDITIONAL INFORMATION:**

- On October 18, 2021, the City of Des entered into a contract with Per Mar Security Services to provide temporary security services at the following municipal facilities City Hall, Argonne Armory and the Municipal Services Center. This contract expires November 30, 2021, and the extension of the Agreement requires City Council approval as the City's costs under the Agreement will exceed \$50,000. The City needs additional time to allow time to develop new job specifications, Civil Service review, and complete the hiring process with the goal of filling these positions with new City staff. It is the intention of the City Manager and staff that extension of the Agreement until May 9, 2022, allowing for early termination by the City, will allow sufficient time to do so.
- The City Manager recommends that the procurement of the above-described services be exempt from the request for proposals process for good cause shown as set forth above, pursuant to Section 2-710(b) of the Municipal Code of the City of Des Moines.
