AGENDA HEADING:

Hearing on 2022 PCC Pavement Patching Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as TK Concrete, Inc., Tony J. Ver Meer, President, \$924,675.

SYNOPSIS:

This is a public hearing to allow for public input on the 2022 PCC Pavement Patching Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for maintenance of Portland Cement Concrete (PCC) streets utilizing full depth removal and replacement of distressed panels.



ADDITIONAL INFORMATION:

- On November 15, 2021, under Roll Call No. 21-1707, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2022 PCC Pavement Patching Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2022 PCC Pavement Patching Program, Activity ID 06-2020-012. The improvement includes removals, drilling and doweling, furnishing, placing, curing, sawing, sealing Portland Cement Concrete (PCC) pavement patches of various thickness, and other incidental items; in accordance with the contract documents, including Plan File No. 636-274/290, at the following locations:
 - o S.W. 37th Street Army Post Road to Gannett Avenue
 - o Gannett Avenue S.W. 37th Street to Dead End East
 - o S.W. 34th Street Army Post Road to Gannett Avenue
 - o Geil Avenue S.W. 14th Street to S.W. 11th Street
 - o 48th Place Urbandale Avenue to Euclid Avenue
 - o E. 21st Street Guthrie Avenue to E. Washington Avenue

- o S.E. 8th Street Pioneer Road to Hartford Avenue

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by TK Concrete, Inc. (Tony J. Ver Meer, President, 1608 Fifield Road, Pella, IA, 50219), in the amount of \$924,675, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
