AGENDA HEADING:

Hearing on 2022 Skywalk Bridge Structural Repair Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as GTG Construction, L.L.C., Tracy D. Grasso, Owner, \$59,000.

SYNOPSIS:

This is a public hearing to allow for public input on the 2022 Skywalk Bridge Structural Repair Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for maintenance and structural repairs to the City's skywalk bridges.

FISCAL IMPACT:



ADDITIONAL INFORMATION:

- On December 20, 2021, under Roll Call No. 21-1882, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2022 Skywalk Bridge Structural Repair Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2022 Skywalk Bridge Structural Repair Program, Activity ID 12-2022-001. The improvement includes the repair of skywalk bridge structural members to include concrete patching, cleaning and painting corroded steel, precast concrete crack repair, and weld repair; all in accordance with the contract documents, including Plan File No. 633-299/310, located at skywalk bridges 2C-3C, 4E-4F, 4F-5F, 5D-5E, 5E-5F, 5E-6E, 7C-8C, 8B-8C, 8C-8D, and 8C-9C, in Des Moines.

- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by GTG Construction, L.L.C. (Tracy D. Grasso, Owner, 6505 Merle Hay Road, Suite A, Johnston, IA, 50131), in the amount of \$59,000, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
