AGENDA HEADING:

Hearing on Animal Control Facility Bid Package No. 17 - Landscaping: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Alpha Landscapes LLC, Riley Marvin, Owner, \$145,950.

SYNOPSIS:

This is a public hearing to allow for public input on the Animal Control Facility Bid Package No. 17 - Landscaping and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. The project provides for the construction of an approximate 21,900-square-foot sustainable animal control facility to be operated by the City's current animal control services contractor, Animal Rescue League of Iowa. The new facility will be located on a 5.5-acre site east of S.E. 14th Street and between Harriet Street and the Des Moines River. The project is intended to better serve Des Moines' residents by replacing the existing outdated and undersized Animal Care and Control Center building. The new facility has been designed and will be submitted for LEED certification.

Amount: \$145,950 Construction Contract (\$170,000 City Engineer's Estimate)

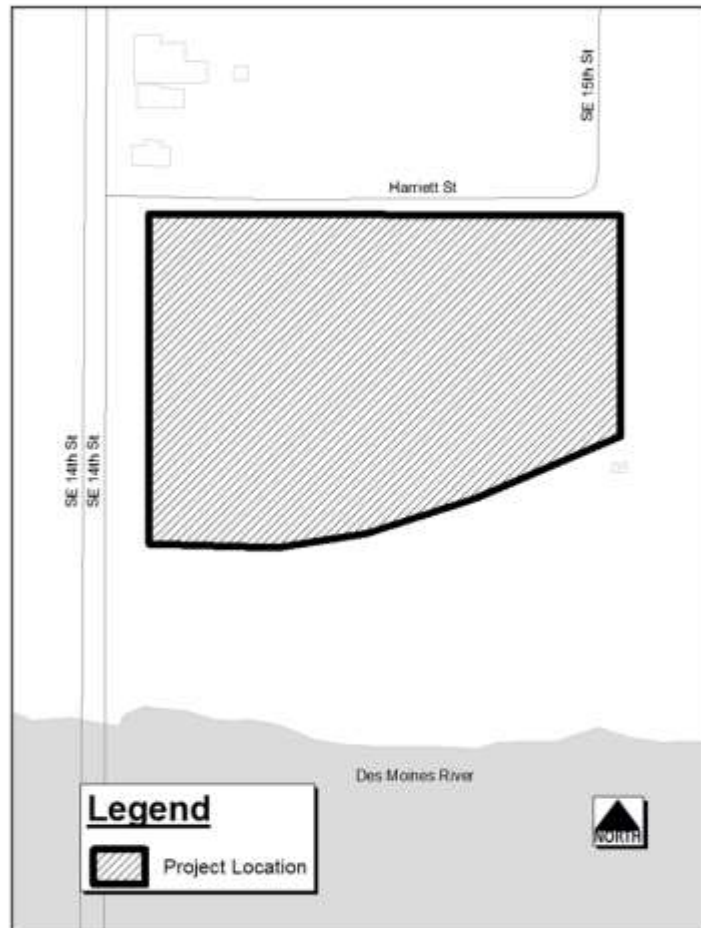

ADDITIONAL INFORMATION:

- On February 7, 2022, under Roll Call No. 22-0150, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Animal Control Facility Bid Package No. 17 - Landscaping. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the Animal Control Facility Bid Package No. 17 - Landscaping, Activity ID 10-2022-018. The improvement includes new construction of an approximately 21,900-square-foot animal care and control facility which includes animal intake and service areas, adoption service areas, animal housing, veterinary clinic with surgery, and drive-thru sally port; design consists of brick masonry base, metal panel and cedar siding, glazed aluminum storefront and windows; wall structure consists of perimeter bearing stud walls and internal steel columns and bearing

concrete masonry walls; floor structure is concrete slab-on-grade; roof structure is metal roof joists and decking; roofing system is a single-ply fully adhered membrane on low slope roof areas; Portland Cement Concrete (PCC) parking lots, PCC sidewalks, sanitary sewer, sanitary sewer manholes, water main, fiber and conduit, chain link fenced outdoor dog runs, surface restoration, and other incidental items; all in accordance with the contract documents associated with Bid Package No. 17 – Landscaping, including Plan File No. 633-001/218, located at 1441 Harriet Street.

- Sealed bids for said improvement were submitted by the following bidders:
 - Alpha Landscapes LLC, Slater, IA, Low Bid
 - Whitfield's Lawn and Garden Specialists, Des Moines, IA - bid not read
 - Tebock's Lawn & Landscape LLC, Ankeny, IA - bid not read
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa at 11:00 a.m. on February 22, 2022.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Alpha Landscapes LLC, (Riley Marvin, Owner, 31273 510th Avenue, Slater, IA, 50244), in the amount of \$145,950, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
