ADDITIONAL INFORMATION:

- The 1998 Quality Housing & Work Responsibility Act requires Housing Agencies to develop and submit to HUD an annual Agency Plan. The recommended plan and policy changes would become effective July 1, 2022, upon Governing Board and HUD approvals.
- The Agency Plan and recommended changes to policies were developed by the Housing Services Board, which held four (4) working sessions to develop the "draft" Agency Plan.
- Notices of the Public Hearing and the availability of the "draft" plan for review and comment were published in the Des Moines Register on January 28, 2022.
- In February 2022 all public housing residents, Section 8 clients, Section 8 owners, Resident Advisory Board Members, community service providers and the Continuum of Care received notice of the availability of the draft plan for review and comment and access to a link on the City web-site to view a slide presentation on the proposed changes. The notice also included an e-mail address to submit any comments on the proposed changes.

- Comments received from those who viewed and commented on the presentation were given to the Housing Services Advisory Board at the March 2022 Board meeting.
- The annual Agency Plan is attached to the associated Roll Call. Upon approval by the Governing Board the final plan will be submitted to HUD prior to April 15, 2022.
