### AGENDA HEADING:

Ordering construction of the following: 2022 Riverwalk Improvements - Balustrade Replacement - Receiving bids, (4-19-22), and Setting date of hearing, (5-23-22). Construction Estimate - \$205,000.

### SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project replaces deteriorated portions of the balustrade wall with a cast stone balustrade wall along both sides of the Des Moines River, south of the Women of Achievement Bridge. The replacement sections of the balustrade wall will replicate the design and appearance of the existing wall.

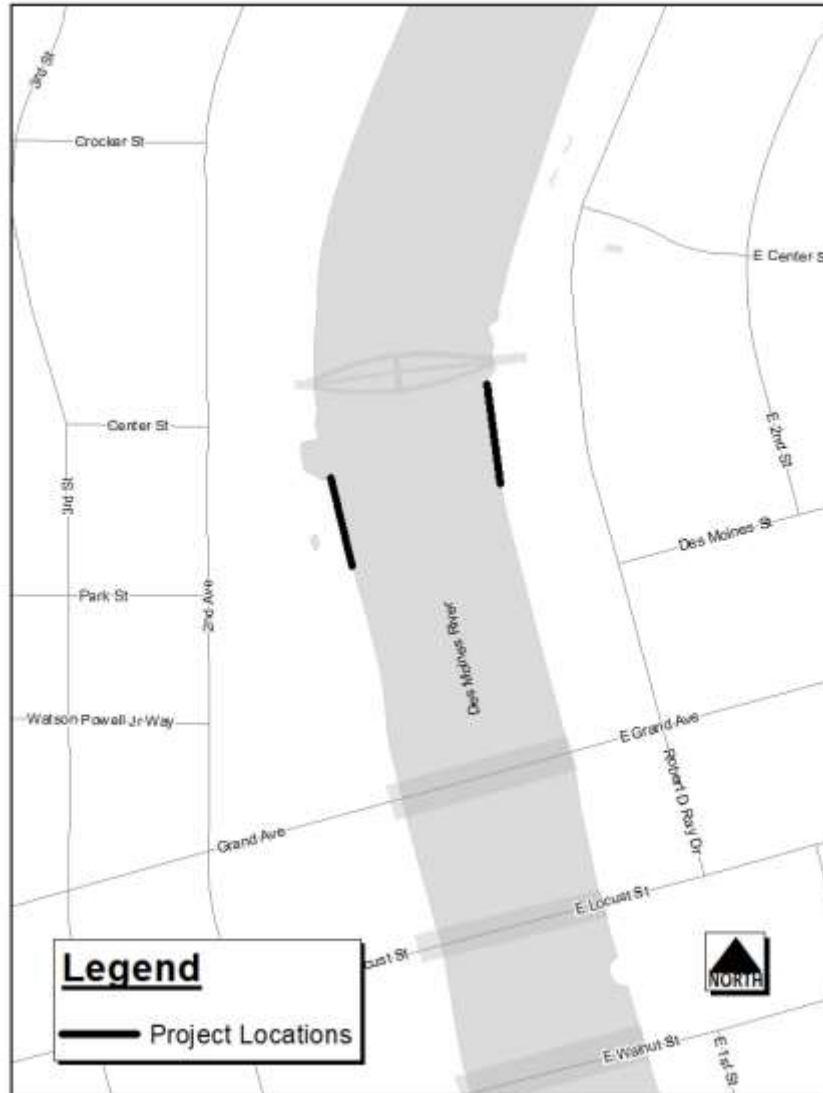
### FISCAL IMPACT:

### ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2022 Riverwalk Improvements - Balustrade Replacement, 04-2022-017. The improvement includes removal of existing sections of balustrade wall and replacement with sections of cast stone balustrade wall; all in accordance with the contract documents, including Plan File No. 641-223/231 located along the east and west side of the Des Moines River, south of the Women of Achievement Bridge.
- The estimated construction cost is \$205,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
- Construction of this project is anticipated to begin in spring 2022 and be completed in summer 2023.
