#### **AGENDA HEADING:**

Approval of parking license agreement between the City of Des Moines and United States General Services Administration (GSA) for parking in the 3rd & Court Parking Garage.

#### **SYNOPSIS:**

City staff has negotiated the terms of a Parking License Agreement with the GSA for the use of 46 parking spaces for a 1-year term commencing April 1, 2022, within the Third and Court Garage to accommodate the users of the Neal Smith Federal Building located at 210 Walnut Street. The proposed Parking License Agreement provides that GSA will pay the prevailing monthly floater rate for each licensed parking space.

### ADDITIONAL INFORMATION:

• This agreement will grant to GSA the right to use 46 non-reserved floater parking spaces in the Third and Court Garage for a term commencing on April 1, 2022, and ending on March 31, 2023, subject, however, to the provisions and limitations set forth in this Agreement. As rental for the parking spaces licensed by the City to GSA under this Agreement, GSA agrees to pay the City a monthly fee of \$5,520.
