### AGENDA HEADING:

Approving the purchase of Gametime Playground Equipment for Evergreen Park from Gametime C/O Cunningham Recreation, and approving use of Omnia Partners Contract No. 2017001134 and agreement with Playcore Wisconsin, Inc. D/B/A Gametime C/O Cunningham Recreation.

### SYNOPSIS:

Recommend approving the procurement of play structures and freestanding play features for Evergreen Park. The play equipment is to be direct sourced from GameTime using the OMNIA cooperative purchasing contract. in the amount of \$134,462.21, utilizing the method of financing referenced below. This equipment will be part of the Evergreen Park Shelter and Playground Improvements scheduled for construction later this fall. The playground equipment will be assembled by volunteers to build community ownership of the playground.

### ADDITIONAL INFORMATION:

- The OMNIA agreement meets all bidding requirements and was vetted and authorized by the Finance Department. Equipment manufacturer shall be GameTime which is of high quality, manufactured in Fort Payne, Alabama. The use of volunteer labor will help build community ownership of the new playground equipment.
- The playground equipment as part of the Evergreen Park Shelter and Playground Improvements project will include new playground equipment (meeting all safety and accessibility standards) in both the 2-year-old to 5-year-old and the 5-year-old to 12-year-old playgrounds.
