#### **AGENDA HEADING:**

Authorization to proceed with acquisition of the necessary property interests for the Hamilton Drain East System Storm Sewer Improvements – Phase 3 Project by gift, negotiation, or eminent domain.

### **SYNOPSIS:**

Recommend approval of authorization to proceed with acquisition of the necessary property interests for the Hamilton Drain East System Storm Sewer Improvements – Phase 3 Project by gift, negotiation, or eminent domain. This action is required by Iowa law before the City can initiate the property acquisition process under eminent domain.

The Hamilton Drain East System Storm Sewer Improvements project will improve drainage in portions of the Highland Park neighborhood. The Hamilton Drain East System Storm Sewer Improvements project includes construction of new storm sewers, replacing an undersized, old wood box culvert to convey stormwater flows, and construction of stormwater detention basins to reduce peak stormwater flows downstream.




<u>Funding Source</u>: 2022-23 CIP, Page 107, Hamilton Drainage Area Improvements, SM133, Being: Storm Water Revenue Bonds and Storm Water Utility Fund.

### **ADDITIONAL INFORMATION:**

- The Hamilton Drain East System Storm Sewer Improvements Phase 3 project provides for construction of new storm sewers, replacing an undersized, old, wood box culvert to convey stormwater flows, and construction of stormwater detention basins to reduce peak stormwater flows downstream.
- At this time, it is anticipated that a total of approximately 26 temporary construction easements, 17 permanent storm sewer and surface water flowage easements, and three (3) partial fee acquisitions are required to be obtained from 33 individual property owners for construction of this project.

• Construction of the Phase 1 Hamilton Drain East System Storm Sewer Improvement Project was completed in 2021 and is in the process of being closed out. Phase 2 of the overall project is currently under construction and is approximately 40% complete.
