AGENDA HEADING:

Approving Professional Services Agreement (PSA) with Foth Infrastructure and Environment, LLC for professional services for E Army Post Road and SE 36th Street Roundabout, for an amount not to exceed \$299,534.

SYNOPSIS:

Approving the PSA with Foth Infrastructure and Environment, LLC (Patrick P. Kueter, Principal-in-Charge, 8191 Birchwood Court, Suite L, Johnston, Iowa, 50131), for a total cost not to exceed \$299,534, based on hourly rates, to provide design and bidding phase services for E Army Post Road and SE 36th Street Roundabout.



<u>Funding Source</u>: 2022-23 CIP, Page 155, E. Army Post Road & SE 36th Street Intersection Improvements, ST303, G.O. Bonds.

ADDITIONAL INFORMATION:

- The project includes the reconstruction of the intersection at E Army Post Road and 36th Street into a roundabout. The roundabout is anticipated to be a single lane roundabout with one (1) lane entering and exiting on each approach. Roundabout improvements will include curb and gutter and extended splitter islands to manage speeds as vehicles approach the roundabout.
- A virtual public meeting was held on July 14, 2020 to review and discuss the proposed project and gather input from affected parties and interested members of the public. The City has funding in Fiscal Years 2025 and 2026 for construction of the roundabout.
- A Request for Proposals (RFP) for design and bidding phase services was issued and posted on the City's website. Seven (7) proposals were received in response to the RFP. The selection committee was comprised of representatives from the Engineering Department. Foth Infrastructure and Environment, LLC was selected based on their qualifications, thorough understanding of the project requirements, project approach, and experience with similar projects.

• City staff negotiated a PSA with Foth Infrastructure and Environment, LLC for a total cost not to exceed \$299,534, based on hourly rates, to provide project/contract management, project coordination, survey, data collection and sub-surface investigation, preliminary design, design phase services and bidding phase services, with construction anticipated to commence in 2025.
