# AGENDA HEADING:

Approving Professional Services Agreement (PSA) with Bolton & Menk, Inc. for professional services for the 2025 Neighborhood Sidewalk Program, for an amount not to exceed \$179,300.

## SYNOPSIS:

Approving the PSA with Bolton & Menk, Inc. (Bradley C. DeWolf, P.E., President/CEO, 1960 Premier Drive, Mankato, Minnesota, 56001-5900), for an amount not to exceed \$179,300, based on hourly rates, to provide design services for the 2025 Neighborhood Sidewalk Program.



## **ADDITIONAL INFORMATION:**

- The City's Neighborhood Sidewalk Program involves constructing new sidewalks to fill sidewalk gaps in the City. The initial priority for recommended improvements is along existing school recommended walk routes, proximity to schools, bus stops and commercial nodes, and/or providing connectivity for long segments of sidewalks.
- The 2025 Neighborhood Sidewalk Program public improvement project includes improvements at the following locations:
  - o 30<sup>th</sup> Street from Urbandale Avenue to Euclid Avenue
  - Prospect Road from 25<sup>th</sup> Street to Martin Luther King Jr. Pkwy.
  - o 25<sup>th</sup> Street from Sheridan Avenue to Prospect Road
  - Cornell Street from E. Sheridan Avenue to Hull Avenue
  - Park Avenue from Wakonda Court to Fleur Drive
  - S.W. 14<sup>th</sup> Street from Watrous Avenue to Park Avenue
  - Park Avenue from S.W. 5<sup>th</sup> Street to South Union Street
  - Philip Street from S.W. 9<sup>th</sup> Street to South Union Street

- A Request for Proposals (RFP) for professional services for 2022-2024 On-Call Sidewalk and Trail Design and Construction Phase Services was issued and posted on the City's website. A selection committee of Engineering Department staff reviewed and rated the 18 proposals received in response to the RFP. Bolton & Menk, Inc. was selected to provide services for this project based upon the selection criteria in the RFP and their thorough project approach, understanding, and related project experience.
- City staff has negotiated a PSA with Bolton & Menk, Inc. for a total cost not to exceed \$179,300, based on hourly rates, to provide Project/Contract Management, Project Coordination, Survey and Data Collection, Right-of-way Acquisition Plats, Design Phase Services and Bidding Phase Services to complete the improvements.
