# AGENDA HEADING:

Approving Supplemental Agreement No. 1 to the Professional Services Agreement (PSA) with Foth Infrastructure and Environment, LLC for additional design and construction phase services for Fleur Drive Reconstruction, Phase 3 from Watrous Avenue to McKinley Avenue, not to exceed \$42,028.

## SYNOPSIS:

Recommend approval of Supplemental Agreement No. 1 to the PSA with Foth Infrastructure and Environment, LLC (Randall J. Homel, President, 2121 Innovation Court, Suite 300, De Pere, Wisconsin 54115), for an additional amount not to exceed \$42,028, based on hourly labor rates and reimbursable costs, for additional design and survey services.



### **ADDITIONAL INFORMATION:**

- The City is in the process of reconstructing Fleur Drive from George Flagg Parkway to McKinley Avenue, including full pavement reconstruction, sidewalks on both sides, water main improvements, and new storm sewer facilities where needed.
- The overall reconstruction project is being completed in three (3) phases:
  - Phase 1 Fleur Drive northbound lanes from George Flagg Parkway to Watrous Avenue completed in 2020.
  - Phase 2 Fleur Drive southbound lanes from George Flagg Parkway to Watrous Avenue currently under construction, anticipated to be completed this year.
  - Phase 3 Fleur Drive northbound and southbound lanes from Watrous Avenue to McKinley Avenue anticipated to start construction this year and be completed in 2024.
- On May 10, 2021, by Roll Call No. 21-216, City Council approved the PSA with Foth Infrastructure and Environment, LLC for a total cost not to exceed \$508,605, based on hourly rates, to provide design phase services for Fleur Drive Reconstruction, Phase 3 from Watrous Avenue to McKinley Avenue.

• Staff negotiated Supplemental Agreement No. 1 to the PSA with Foth Infrastructure and Environment, LLC for an additional amount not to exceed \$42,028, based on hourly rates and reimbursable costs, to provide additional design services to include reconstruction of a 500-feet section of pavement along McKinley west of the Fleur Drive/McKinley Avenue intersection, additional survey, additional traffic control, and some construction administration services related to Fleur Drive Reconstruction, Phase 3 from Watrous Avenue to McKinley Avenue.
