# AGENDA HEADING:

Resolution Approving Seventh Amendment and Supplement to Skywalk Agreement with Employers Mutual Casualty (EMC) Company for the property located at 701 Walnut Street.

#### SYNOPSIS:

The property at 701 Walnut Street is subject to a Skywalk Agreement originally adopted in 1981. EMC is the successor in interest of the Skywalk Agreement affecting this property.

The purpose of this Seventh Amendment is to remove Skywalk Bridge 7C-7D and the south half of the Skywalk Corridor 7D(s) from the official skywalk map. This Seventh amendment will also extend the Skywalk Agreement terms until 2042.

## FISCAL IMPACT: NONE

## **ADDITIONAL INFORMATION:**

- In 2021, the City demolished Skywalk Bridge 7C-7D and reopened the Walnut Street right-of-way.
- Also in 2021, EMC presented plans to the City for construction of an Urban Park located at 701 Walnut Street, which is currently under lease to the City. With the construction of the Urban Park, the Skywalk Bridge 7C-7D and the south half of the Skywalk Corridor 7D(s) were requested by EMC to not be rebuilt in their former locations, and therefore removed from the official skywalk map.
- This Skywalk Amendment also directs construction of a stairway connecting the Urban Park to the skywalk system. This is to be completed by December 31, 2023. The stairway will be maintained as a point of public ingress and egress during the hours of the Urban Park, 6:00 a.m. and 10:00 p.m.
