# AGENDA HEADING:

Approving Des Moines Municipal Housing Agency's (DMMHA) revised payment standards for the Section 8 Housing Choice Voucher Program.

## SYNOPSIS:

Approval of the DMMHA's revised payment standards for the Section 8 Housing Choice Voucher Program as required by the U.S. Department of Housing and Urban Development (HUD).

## FISCAL IMPACT: NONE

# **ADDITIONAL INFORMATION:**

- The DMMHA provides decent, safe and affordable housing to low-income families within Des Moines and Polk County.
- HUD provides an annual review of Fair Market Rents (FMR) for geographical locations throughout the United States.
- The DMMHA must set its payment standard between 90% and 110% of the HUD-established FMR.
- The DMMHA is requesting approval to revise its payment standards to be effective January 1, 2023, to be in compliance with the 2023 HUD-established FMR's, increasing all bedroom size payment standards to 100% of the FMR.
- The DMMHA acknowledges the current state of the economy, continues to dramatically affect the local rental market where rental rates continue to increase making it increasingly more difficult for voucher holders to locate available rental units at the existing payment standards
- The recommended revised payment standards are listed below:
