AGENDA HEADING:

Approving Professional Services Agreement (PSA) with Olsson, Inc. for Traffic Engineering Services for the Traffic Signal System Timing Updates – Phase 5, for an amount not to exceed \$334,958.23.

SYNOPSIS:

Recommend approval of the PSA with Olsson, Inc. (Ryan Beckman, President, 601 P Street, Suite 200, Lincoln, Nebraska 68508), for a total cost not to exceed \$334,958.23, based on hourly rates, to provide traffic engineering services for Traffic Signal System Timing Updates – Phase 5. The project is the fifth and final phase of a multiphase project to update signal timing and phasing for all of the traffic signals in Des Moines.




<u>Funding Source</u>: 2022-2023 CIP, Page Streets – 174, Traffic System Operation Improvements, TR097, being: \$232,000 – Iowa Department of Transportation (IDOT) Iowa Clean Air Attainment Program (ICAAP) grant funds (secured) and \$102,958.23 in G.O. Bonds.

ADDITIONAL INFORMATION:

- This project will be the fifth and final phase of a multi-phase effort to review and update the signal timing and phasing for all the City's traffic signals. The goal of the project is to increase efficiency of the traffic signal systems resulting in decreased travel times, reductions in traffic congestion, and ultimately the reduction of vehicle emissions. The project will also consider signal timing and phasing for pedestrian and bicycle traffic in support of the City's efforts to provide a more walkable and bikeable transportation network.
- The overall purpose of this project is to prepare optimized traffic signal timings and phasing plans for traffic signals in the downtown area including 85 traffic signals, four (4) signalized pedestrian crossings and the following 12 study corridors in Phase 5:
 - \circ Grand Avenue 2nd Avenue to 18th Street
 - Locust Street 18th Street to 2nd Avenue

- o 2nd Avenue Court Avenue to Interstate 235
- o 3rd Street Interstate 235 to Court Avenue
- $\circ \quad 5 th \ A venue-Interstate \ 235 \ to \ Cherry \ Street$
- 6th Street Cherry Street to Interstate 235
- $\circ \quad \mbox{7th Street} \mbox{Interstate 235 to Cherry Street}$
- $\circ \quad 8 th \; Street-Mulberry \; Street \; to \; Center \; Street$
- o 9th Street Keosauqua Way to Mulberry Street

• The five (5) phases of the Traffic Signal System Timing Updates project are shown on the map below:

- The City Engineer recommends that good cause exists to exempt the procurement of these professional services from the Engineering Department's Request for Proposal (RFP) process, including advertisement, for project design and schedule efficiencies. Olsson, Inc. is qualified to perform the professional services and was selected to complete the Traffic Signal Timing Updates Phase 5 Services based on:
 - The consultant completed Phases 1-3 of the Traffic Signal Timing Updates.
 - The consultant is currently under contract to complete Phase 4 of the Traffic Signal Timing Updates.
 - The consultant's familiarity with the City.
 - The consultant's experience with traffic signal timing services.
- City staff has negotiated a Professional Services Agreement (PSA) with Olsson, Inc. for a total cost not to exceed \$334,958.23, based on hourly rates, to provide traffic engineering services.
- Due to this project being funded primarily by IDOT ICAAP grant funds, the IDOT Standard Consultant Contract document and associated terms and conditions will be used for this project in lieu of the City's standard PSA document.
