### **AGENDA HEADING:**

Amending Chapter 114 of the Municipal Code regarding Traffic Regulation Changes as follows:

- A. Code changes to establish a passenger loading and unloading zone on 7th Street between Grand Avenue and Locust Street.
- B. Code change to match field conditions on 6th Avenue between Grand Avenue and High Street.

Recommend approval of the staff recommendation and the ordinance regarding the traffic regulation changes.


### **FISCAL IMPACT:**

# **ADDITIONAL INFORMATION:**

A. As a result of a curb extension (bump-out) project, a passenger loading zone and metered parking is proposed to be added to the east side of 7th Street between Locust Street and Grand Avenue. This proposed action will revise the Municipal Code to reflect the change.




Sec. 114-2664. Seventh Street--Locust Street to Grand Avenue.

Seventh Street, on the east side, from Locust Street to Grand Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Saturday.

Seventh Street, on the east side, from a point 40 feet south of Grand Avenue to a point 60 feet south thereof, passenger loading and unloading zone, 10 minutes only.

B. During a field review, an inconsistency of the time-of-day parking restrictions along 6th Avenue on the east side from Grand Avenue to High Street was discovered. Sixth Avenue, south of Grand Avenue and north of High Street has signage in place to restrict parking from 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m., Monday through Friday; however, the Municipal Code states no parking anytime. This proposed action will amend the Municipal Code to match the signage in the field.



Sec. 114-2643. Sixth Avenue—Grand Avenue to High Street.

Sixth Avenue, on the east side, from a point 130 feet north of Grand Avenue to High Street, no parking any time 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the west side, from Grand Avenue to High Street, no parking 4:00 p.m. to 6:00 p.m.
