# AGENDA HEADING:

Approving 28E Agreement Between the City of Des Moines and the City of West Des Moines for Major Reconstruction of 63rd Street/SE 1st Street from Willow Creek Avenue/ SE Willow Creek Drive (Formerly Army Post Road) to the Dead End North of Willow Creek Avenue/SE Willow Creek Drive (Formerly Army Post Road).

## SYNOPSIS:

SW 63<sup>rd</sup> Street is a boundary street shared by the cities of West Des Moines and Des Moines. The maintenance of boundary streets is defined by an existing 28E agreement. Major maintenance for the boundary streets is shared by the entities. This street requires a mill and overlay estimated to cost \$265,700, with costs to be shared equally.

### FISCAL IMPACT:

Amount: \$132,850 (half of \$265,700)

<u>Funding Source</u>: 2022-2023 CIP, Page Streets – 116, Roadway Rehabilitation - Collector, ST217, Gaming Monies.

### **ADDITIONAL INFORMATION:**

- In April 2005, the cities of West Des Moines and Des Moines approved the 28E Agreement Between the City of West Des Moines, Iowa and the City of Des Moines, Iowa Boundary Streets Joint Agreement.
- The agreement addresses the general maintenance of boundary streets and outlines a process for major reconstruction as any project greater than 50 square yards of contiguous or proximate paving, shall be accomplished by mutual agreement between West Des Moines and Des Moines.
- This project's size requires a new one-time, mutual agreement.
- The City of Des Moines shall administer the contract to mill and overlay SW 63<sup>rd</sup> Street. The actual cost of construction will be shared equally between the two (2) entities.
- This project will be accomplished by December 31, 2023.
