
FISCAL IMPACT:

Amount: \$150,000 plus closing costs.

ADDITIONAL INFORMATION:

- CFUM, LLC, the owner of 1600 9th Street, has agreed to voluntarily sell the property to the City of Des Moines for the North Side Community Recreation Center Project.
- The City's Real Estate Division reached a voluntary agreement with CFUM, LLC. for a purchase price of \$150,000, plus closing costs. The property to be acquired consists of approximately 48,587 square feet and the purchase price is equal to the estimated fair market value of the property, as determined by an independent appraisal obtained by the City's Real Estate Division.
- The property being acquired will be dedicated as parkland to support the North Side Community Recreation Center project, with dedication being effective upon acquisition/closing.
