# AGENDA HEADING:

Ordering construction of the following: 2023 HMA Resurfacing Program Contract 1 - Receiving bids, (2-7-23), and Setting date of hearing, (3-6-23). Construction Estimate - \$1,200,000.

### SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for resurfacing of roadways utilizing surface scarification and Hot Mix Asphalt (HMA) overlay to improve the surface condition and to extend the useful service life of the streets.



### **ADDITIONAL INFORMATION:**

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2023 HMA Resurfacing Program Contract 1, Activity ID 062022007. The improvements include scarification of existing asphalt streets, furnish and place HMA, furnish and place pavement markings, traffic control and other incidental items; all in accordance with the contract documents, including Plan File No. 652-157/196, at the following locations and other locations in the City as directed by the Engineer:
  - SW 23rd Street Bell Avenue to Park Avenue
  - Bell Avenue SW 23rd Street to SW 30th Street
  - o Indianola Road South Union Street to SW 7th Street
  - Douglas Avenue 6th Avenue to 11th Street
  - E Walnut Street E 18th Street to E 22nd Street
- The estimated construction cost is \$1,200,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

• Construction of this project is scheduled to begin in summer 2023 and be completed in summer 2024. Work on the SW 23<sup>rd</sup> Street and Indianola Road locations will be completed during summer break while school is not in session.
