# AGENDA HEADING:

Approving replenishment of blanket purchase order for auto body repairs for use in various City departments.

# SYNOPSIS:

Recommend approval of the purchase of auto body repairs services including labor and parts for the repair of City vehicles in various departments utilizing the State of Iowa, Department of Administrative Services purchasing contract number 22044 from Stew Hansen Dodge City (12103 Hickman Road, Des Moines, IA 50323, Dan Boettcher, General Manager), in the amount of \$200,000.

# **ADDITIONAL INFORMATION:**

- Upon the retirement of the City's auto body repair mechanic on July 27, 2021, in house auto body repair operations ceased, resulting in a need to fully contract for these services. Various auto body repair shops with State of Iowa Department of Administrative Services (IDAS) contracts have been utilized for repairs to City vehicles during the past two (2) years.
- Additionally, the Fleet Division maintenance repair space in MSC2 does not have auto body repair bays. The new facility was specifically designed without the incorporation of specialized work bays for vehicle preparation and a sophisticated finish paint booth and bay. Therefore, there is an ongoing need for contracted auto body repairs. Due to an increase in auto body repairs services, it is necessary to increase the existing blanket purchase order with the selected vendor.
- Various State of IDAS purchasing contracts that provide auto body repair services were evaluated by staff for potential use. The selected vendor continues to meet the City's increased need for additional auto body repairs.

• This purchase order will work in conjunction with Agenda Item No. 39, allowing for Fleet to procure the quickest turnaround time for auto body repairs.
