AGENDA HEADING:

Ordering construction of the following: New York Avenue from 44th Street to 45th Street Reconstruction - Receiving bids, (3-7-23), and Setting date of hearing, (3-27-23). Construction Estimate - \$370,000.

SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project includes full reconstruction of the roadway pavement on New York Avenue between 44th Street and 45th Street, including the intersection of 45th Street to address pavement drainage issues. This project also adds sidewalk along the south side of New York Avenue between 44th Street and 45th Street.



ADDITIONAL INFORMATION:

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the New York Avenue from 44th Street to 45th Street Reconstruction, Activity ID 062022002. The improvement includes roadway reconstruction with Portland Cement Concrete (PCC) pavement with integral curbs, modified subbase, subdrain, PCC driveways, pavement removal, grading, PCC sidewalk, storm sewer, traffic control, surface restoration, and other incidental items, all in accordance with the contract documents including Plan File No. 654-001/022, located on New York Avenue from 44th Street to 45th Street.
- The estimated construction cost is \$370,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.

• Construction of this project is anticipated to begin in spring 2023 and be completed in fall 2023.
