# AGENDA HEADING:

Ordering construction of the following: 2023 Hot Mix Asphalt (HMA) Resurfacing Program Contract 2 - Receiving bids, (4-11-23), and Setting date of hearing, (5-8-23). Construction Estimate - \$1,125,000.

# SYNOPSIS:

Recommend the City Council order construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project provides for the resurfacing of roadways, utilizing surface scarification and HMA overlay to improve the surface condition and to extend the useful service life of the streets.



#### **ADDITIONAL INFORMATION:**

- The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2023 HMA Resurfacing Program Contract 2, Activity ID 062022008. The improvements include scarification of existing asphalt streets, furnish and place HMA, furnish and place pavement markings, traffic control and other incidental items, all in accordance with the contract documents, including Plan File No. 654-178/208, at the following locations and other locations directed by the Engineer in Des Moines:
  - 43rd Street Ingersoll Avenue to Grand Avenue
  - 27th Street and Lincoln Avenue Allison Avenue to 26th Street
  - Center Street 12th Street to 15th Street
  - Pioneer Road SE 6th Street to Indianola Avenue
  - Watrous Avenue SW 14th Street to Fleur Drive
  - o SW 10th Place Southdale Drive to County Line Road
  - o SW 11th Street Southdale Drive to County Line Road

- The estimated construction cost is \$1,125,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
