AGENDA HEADING:

Acceptance of a proposal from MidAmerican Energy Company to replace 16 existing streetlight poles and install 12 new streetlight poles for E. Court Avenue Reconstruction from the Des Moines River to E. 7th Street, estimated at \$191,264.55.

SYNOPSIS:

Recommend acceptance of a proposal from MidAmerican Energy Company (200 SE 3rd Street, Des Moines, Iowa, 50309) to replace 16 existing streetlight poles with 16 new black streetlight poles with LED lighting and install 12 new black streetlight poles with LED lighting for E. Court Avenue Reconstruction from the Des Moines River to E. 7th Street.



ADDITIONAL INFORMATION:

- On January 9, 2023, by Roll Call Numbers 23-0067 and 23-0068, City Council held a hearing and awarded the construction contract for the E. Court Avenue Reconstruction from the Des Moines River to E. 7th Street project, which includes full reconstruction of E. Court Avenue from the Des Moines River to east of E. 7th Street, including sidewalk, buffered bike lanes, storm sewer, and water main improvements. Construction of this project is anticipated to be completed by fall 2024.
- The proposal provides for MidAmerican Energy Company to:
 - o Replace 16 streetlight poles with 16 new, black, galvanized, steel poles with LED streetlights.
 - o Install 12 new black, galvanized, steel poles with LED streetlights.
- The LED light fixtures will be installed on black, steel poles and served by underground conductors and are to be billed to the City at the wood pole overhead rate. The estimate from MidAmerican Energy for the work is \$191,264.55 and is budgeted as part of the E. Court Avenue Reconstruction project costs.
