AGENDA HEADING:

Hearing on North Valley Drive and Grand Avenue Sidewalk and Railroad Crossing Improvements: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as TK Concrete, Inc., Tony J. Ver Meer, President, \$580,895.

SYNOPSIS:

This is a public hearing to allow for public input on the North Valley Drive and Grand Avenue Sidewalk and Railroad Crossing Improvements and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the construction of new sidewalks along North Valley Drive between the Bill Riley Trail and 56th Street. The project also replaces the approach paving and sidewalks at the North Valley Drive and Grand Avenue railroad crossings with Iowa Interstate Railroad. The project is in coordination with the Iowa Interstate Railroad, who will be replacing the surface panels and ties to improve the condition of the railroad crossings. In accordance with the Iowa Department of Transportation (IDOT) policy, an overall agreement of shared responsibilities between IDOT, Iowa Interstate Railroad, and the City of Des Moines will be presented to City Council after bids are received and approved for the Grand Avenue railroad crossing replacement.



Bonds, anticipated \$65,000 in Federal funds from Iowa DOT, and the remaining \$70,000 in G.O. Bonds transferred from 2023-24 CIP, Page 115, Railroad Crossing Surface Repairs & Signal Improvements, ST139, and the remaining \$73,000 in G.O. Bonds transferred from 2023-24 CIP, Page 176, Traffic Calming Improvements, TR032

ADDITIONAL INFORMATION:

• On April 10, 2023, under Roll Call No. 23-0473, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the North Valley Drive and Grand Avenue Sidewalk and Railroad Crossing Improvements. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed

plans, specifications, and form of contract documents and engineer's estimate for the construction of the North Valley Drive and Grand Avenue Sidewalk and Railroad Crossing Improvements, Activity ID 04-2023-009. The improvement includes earthwork, Portland Cement Concrete (PCC) sidewalks, PCC curb and gutter, PC driveways, pavement removal, Hot Mix Asphalt (HMA) street approaches, pavement markings, new storm sewer and storm sewer intakes, signage and other incidental items; all in accordance with the contract documents, including Plan File No. 655-001/043, along the Iowa Interstate Railroad near North Valley Drive and Grand Avenue in the City of Des Moines, IA.

- Sealed bids for said improvement were submitted by the following bidders:
 - o TK Concrete, Inc., Pella, IA Low Bid
 - o Minturn, Inc., Brooklyn, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA, at 11:00 a.m. on April 25, 2023.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by TK Concrete, Inc., Tony J. Ver Meer, President, 1608 Fifield Road, Pella, IA, 50219 in the amount of \$580,895, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- On April 17, 2023, Addendum No. 1 to the bidding documents was issued, which added a raised crosswalk on North Valley Drive to the scope of work to be completed for this project. As a result of the additional work added by Addendum No. 1, the original construction estimated of \$365,000 was revised to \$420,000.
- Construction of this project is anticipated to be completed in the fall of 2023.
