AGENDA HEADING:

Hearing on SW 63rd Street Resurfacing from Willow Creek Drive to Dead End North: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Kevin Bragg, President, \$264,096.20.

SYNOPSIS:

This is a public hearing to allow for public input on the SW 63rd Street Resurfacing from Willow Creek Drive to Dead End North and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the resurfacing of SW 63rd Street, utilizing surface scarification and Hot Mix Asphalt (HMA) overlay to improve the surface condition and extend the useful service life of the street.

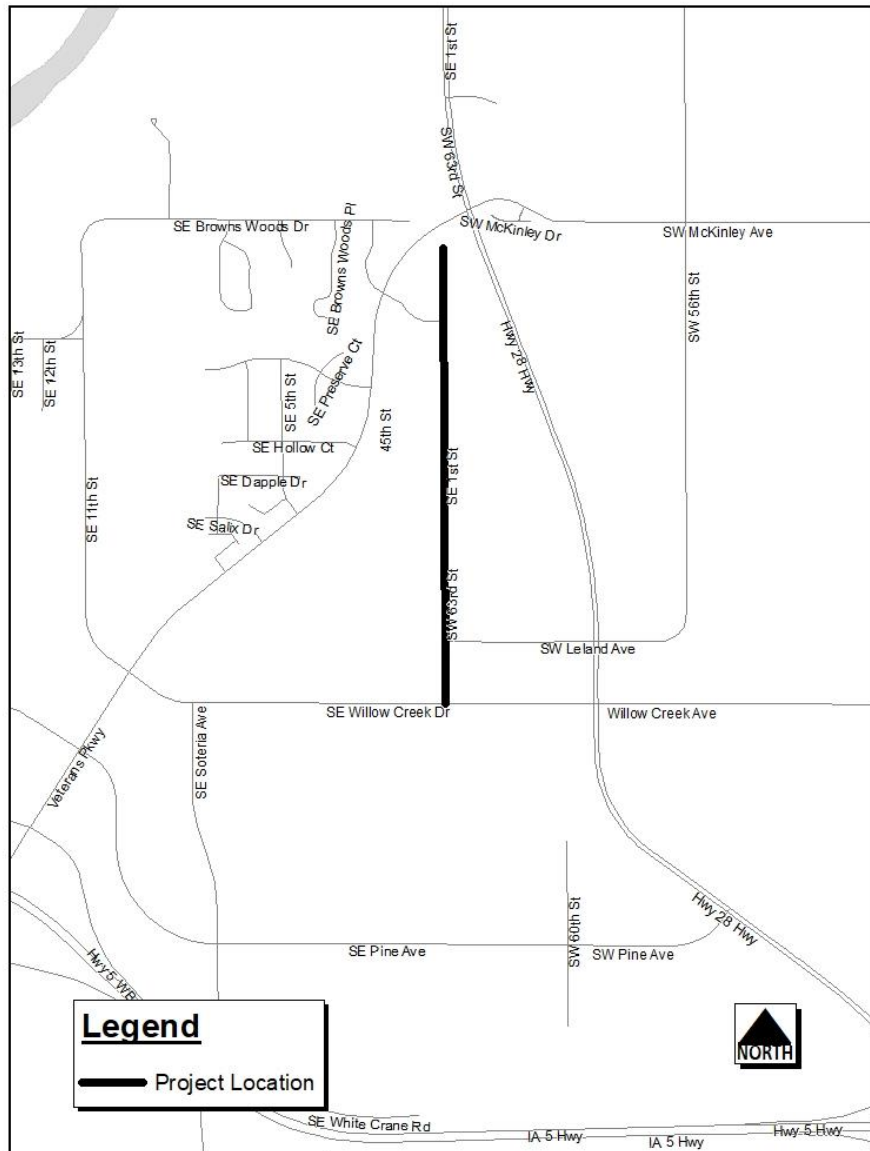
Amount: \$264,096.20 Construction Contract (\$370,000 City Engineer's Estimate)

Funding Source: 2023-24 CIP, Page 117, Roadway Rehabilitation – Collector, ST217, Being: \$132,048.10 in Gaming Monies and the remaining \$132,048.10 from the City of West Des Moines

ADDITIONAL INFORMATION:

- On April 10, 2023, under Roll Call No. 23-0472, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SW 63rd Street Resurfacing from Willow Creek Drive to Dead End North. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the SW 63rd Street Resurfacing from Willow Creek Drive to Dead End North, Activity ID 06-2023-009. The improvements include scarification of existing asphalt street, furnish and place Hot Mix Asphalt (HMA), furnish and place pavement markings, traffic control and other incidental items; all in accordance with the contract documents, including Plan File No. 655-044/056, on SW 63rd Street from Willow Creek Drive to dead end north, Des Moines, Iowa.

- Sealed bids for said improvement were submitted by the following bidders:
 - OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Ankeny, IA - Low Bid
 - InRoads, LLC, Des Moines, IA
 - Grimes Asphalt and Paving Corporation, Des Moines, IA
- The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. Ray Drive, Des Moines, IA at 11:00 a.m. on April 25, 2023.
- The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc. dba Des Moines Asphalt & Paving, Kevin Bragg, President, 2401 SE Tones Drive, Ste. 13, Ankeny, IA, 50021 in the amount of \$264,096.20, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
- Construction of this project is anticipated to be completed in the summer of 2023.
